

■ MANUFACTURE

This Reference Product comes from sites that has received ISO14001 certification.



■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over a maximum distance of 1405 km by road from our warehouse to the local point of distribution into the market in Europe.

Packaging is compliant with European directive 2004/12/EU concerning packaging and packaging waste. At their end of life, its recyclability rate is 86 % (in % of the mass of the packaging).

END OF LIFE

The product end-of-life factors are taken into account during the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse.

• Recyclability rate:

Calculated using the method described in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 94 %. This value is based on data collected from a technological channel using industrial procedures. It does not pre-validate the effective use of this channel for end-of-life electrical and electronic products.

Separated into:

- plastic materials (excluding packaging) : 48 %
- metal materials (excluding packaging) : 18 %
- packaging (all types of materials) : 28 %



ENVIRONMENTAL IMPACTS

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use and end-of-life. It is representative from products marketed and used in Europe, in compliance with the local current standards.

For each phase, the following modelling elements were taken in account:

Manufacture	Materials and components of the product, all transport for the manufacturing, the packaging and the waste generated by the manufacturing.
Distribution	Transport between the last Group distribution centre and the farthest delivery point in the sales area.
Installation	The end of life of the packaging.
