
Description of the product

The use phase has the greatest impacts contribution on the majority of environmental indicators, except for Climate change-Land use and land use change (PEF-GWPlu), Ozone depletion(PEF-ODP), Resource use minerals and metals(PEF-ADPe), Water Use (PEF-WU). this contribution is mainly due to the energy consumption throughout the product reference service lifetime.
