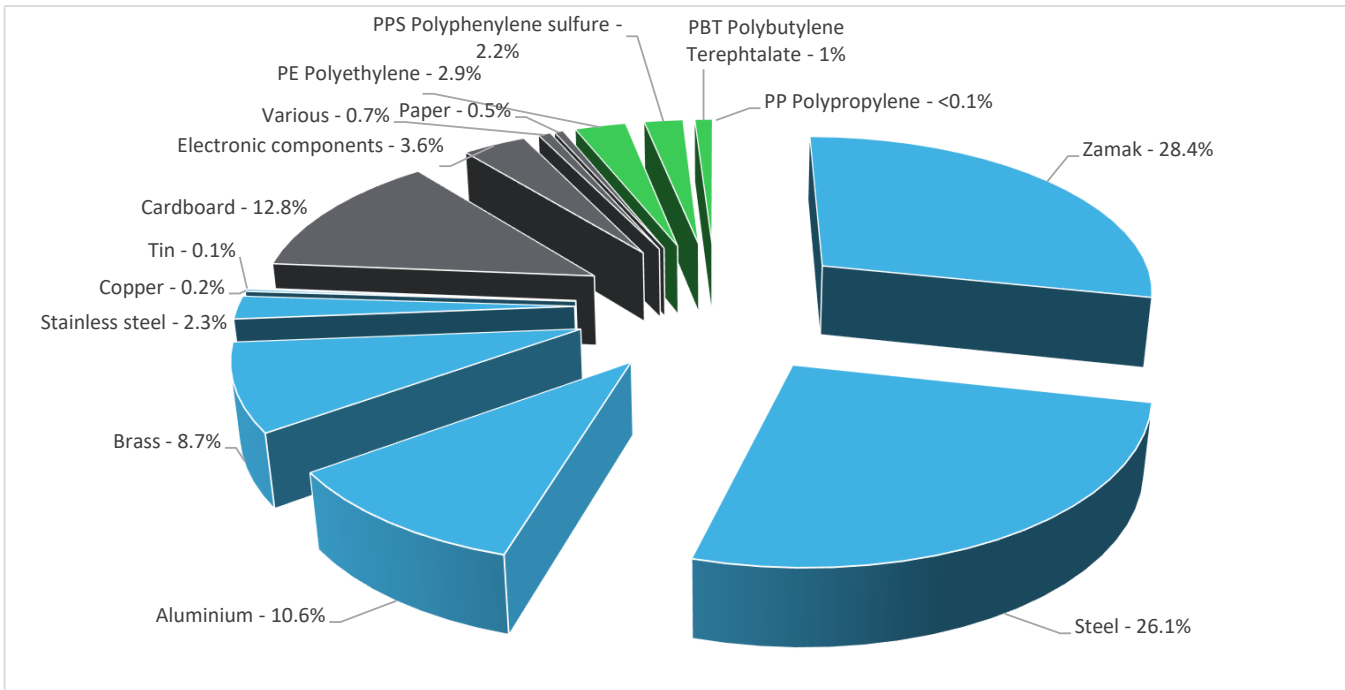
## General information

<b>Representative product</b>	Lexium Integrated Drive ILE - ILE1F662S2017
<b>Description of the product</b>	The main purpose of the Lexium Integrated Drive ILE is to control the variation of the rotational speed and position of a DC brushless electric motor.
<b>Description of the range</b>	This range consists of Integrated Drives ILE with brushless DC motors with ratings from 3.8A to 5A for operation on 24V to 36V, DC-Supply.  The environmental impacts of this referenced product are representative of the impacts of the other products of the range which are developed with a similar technology.
<b>Functional unit</b>	To coordinate and synchronize motion control with stepper, servo or burshless DC motor 70% of the time for 10 years.

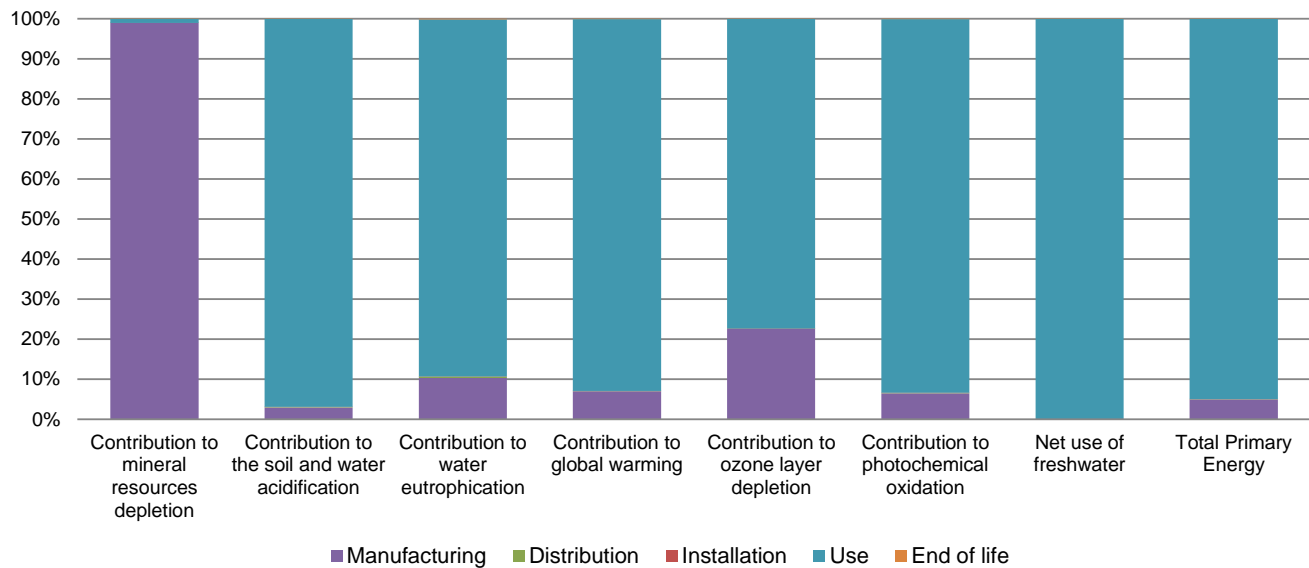

The use phase is the life cycle phase which has the greatest impact on the majority of environmental indicators (based on compulsory indicators).

Depending on the impact analysis, the environmental indicators (without "contribution to Mineral Resources Depletion" and "contribution to ozone layer depletion") of other products in this family may be proportional extrapolated by energy consumption values. For mineral Resources Depletion, impact may be proportional extrapolated by mass of the product. For ozone layer depletion, 20% is caused by manufacturing and 80% is caused by the use phase therefore 20% of the impact may be proportional extrapolated by mass of the product and 80% may be proportional extrapolated by energy consumption values.
